

Whereas. I , the said Edd Butler in and by certain

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land lying and being in Austin Township, Greenville County, State of South Carolina, bounded by lands now or formerly owned by R. H. Morton, J. B. Brown, J. B. League and others, containing 15 acres more or less, and being the identical tract of land conveyed to mortgagor by J. M. Latta by deed dated January 5, 1922 and recorded in Vol. 87, page 241 in the Greenville County R. M. C. Office. For a more definite description reference is here made to above deed and courses and distances, metes and bounds as described therein are here made a part and parcel of this instrument.
