All that tract or lot of land in Greenville County, State of South Carolina, in the City of Greenville, on the West side of Pendleton Street, beginning at a point in the middle of the Southern end of the East wall of Sunie F. Ferguson and running through said wall and 15 feet beyond said wall to a stone, the total length of this line being 160 feet; thence N. 71-30 E. 50 feet to a stone, which stone is 100 feet back from Pendleton Street; thence S. 18-30 E. 100 feet to Pendleton Street; thence along the West side of Pendleton Street S. 71-30 W. 50 feet to the point of beginning.
