Beginning at an iron pin in the southeastern margin of South Carolina Highway No. 14, approximately 3 1/2 miles from Greer, South Carolina, said beginning point being the northwestern corner of lot No. 3 as shown on a Plat of the Mamie Burnett Estate Subdivision; and running thence south 77 degrees 52 minutes east 669 feet to an iron pin in the Egbert Mosteller Estate Property; thence with the Mosteller line north 21 degrees 58 minutes east 150 feet to an iron pin; thence north 80 degrees 38 minutes west 603.6 feet to an iron pin the southeastern margin of Highway 14; thence with the margin of said Highway south 49 degrees 50 minutes west 150 feet to the beginning.
