Hawkins, and running thence along the line of said property, S. 5-00 W. 180 feet to an iron pin at the joint corner of property now or formerly of Monroe Fowler; thence along the line of said property, S. 79-30 E. 59.2 feet to an iron pin; thence continuing still along the line of said property S. 63-00 E. 38.6 feet to an iron pin; thence N. 10-16 E. 180 feet to an iron pin on the southwesterly side of the right-of-way of the Old U. S. Highway No. 276; thence along the southeasterly side of said right-of-way, N. 63-00 W. 114.6 feet to the point of beginning.
