NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southern side of Magnelia Street, in Bates Township, Greenville County, and being shown and designated as Lot 25 on plat of property of John and Lynell Peterson, recorded in Plat Book PP at Page 85, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Magnolia Street, at joint front corner of Lots 25 and 24, and running thence with line of Lot 24, S. 48-15 W. 150 feet to pin at corner of Lot 29; thence with line of Lot 29, N. 45-15 W. 100 feet to pin in rear line of Lot 27; thence with rear line of Lots 27 and 26, N. 48-15 E. 150 feet to pin on Magnolia Street; thence with the southern side of Magnolia Street S. 45-15 E. 100 feet to the paint of beginning; said premises being a portion of the property conveyed to John Peterson and Lynell Peterson by deed recorded in Book of Deeds 464 at Page 348; Jehn Peterson having conveyed his interest in the mortgaged premises by deed to be recorded herewith."
