C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Crtizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the Town of Green, S. C. and in the section known as Needmore, shown as Lot No. 9 on plat of property of Ella Rector, said plat made by H. S. Brockman, Surveyor, July 12th, 1947, and having the following courses and distances, to wit:-

Lying on the north side of Ashmore Street, being bounded on the north by lands of Mrs. Gena Caldwell, on the east by Lot No. 10, on the south by the said Ashmore Street and on the west by Lot No. 8, and having the following courses and distances, to wit:-

HEGINNING on a stake on north side of Ashmore Street, joint corner of lots Nos. 9 and 10, and runs thence with the common line of these two lots, N. 12-20 E. 150 feet to a stake on the Caldwell line; thence with this line, N. 77-40 W. 50 feet to a stake, joint corner of lots 8 and 9; thence with the common line of these two lots, S. 12-20 W. 150 feet to a stake on the north side of Ashmore Street; thence with the north side of Ashmore Street 8. 77-40 E. 50 feet to the beginning corner.
