Court of said state, at chambers or otherwise, or to may Judge of the County Court in any county which has a county court, for the appointment of a receiver, with mathematy to take possession of said premises and collect said rents and profits, applying the said profits (after paying the cast of collection) upon said debt, interest, cost and expenses without liability to account for anything more than the rests and profits actually collected.
