All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, known as lot 40, Hunters Acres, near Simpsonville, S. C., and having, according to plat entitled Map of Hunters Acres recorded in plat book BB at page 51, the following metes and bounds, to-wit:

Beginning at a point on the northwest side of Pine Lane (Florence Drive) at the joint front corner of lots 40 and 41, and running thence S 1-07 W, 80 feet to an iron pin; thence N 88-53 W, 312 feet to an iron pin, located 10 feet from branch line; thence along the meanders of said branch as a line by a traverse line, N 52-2 E, 90.1 feet to an iron pin; thence continuing along said branch as a line by a traverse line 23.12 feet to an iron pin which is situated 20 feet from said branch; thence S 80-00 E, 237.8 feet to the beginning corner and being the same property conveyed to us by deed of Poinsett Realty Company, Inc., to be recorded of even date herewith.
