All that certain piece, parcel or lot of land situate, lying and being on the northern side of Hartsville Street, near the City of Greenville, State of South Carolina, being known and designated as Lot #204, as shown on a plat prepared by J. Mac Richardson, R. L. S., dated February 1961, entitled, "Final Plat - Section Three - Orchard Acres", and recorded in the R. M. C. Office for Greenville County in Plat Book QQ at page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Hartsville Street, the joint front corner of lots #204 and #203, and running thence along the line of lot #203, N. 3-21 W. 175 feet to an iron pin in the property line; thence along the property line, N. 88-21 E. 106.4 feet to an iron pin in the line of lot #206; thence S. 1-59 W. 172.5 feet to an iron pin on the northern edge of Hartsville Street; thence along the northern edge of Hartsville Street, S. 86-39 W. 90 feet to an iron pin, point of beginning, being the same conveyed to me by Leslie & Shaw, Inc. by deed of even date, to be recorded herewith.
