"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Treenville, Chick Springs
Township, near the Pleasant Grove Baptist Church about one mile southwest of the City of Treer, on the south east side of the Brushy Creek Road (Highway S.-94), and being shown on plat of property made for John H. Greer by John A. Sirmons, Registered Surveyor, dated May, 1960, and subsequently revised, recorded in rlut Book PP, page 121, R.M.C. Office for Greenville County, and having the following courses and distances,

BEGIN ING at an iron pin on the southeastern side of the Brushy Creek Road, (Highway 6-94), at the corner of a 10 foot strip owned by Joseph Tyminski, and running thence along the Tyminski line, S. 39-53 E. 211.4 feet to an iron pin o the line of Lot No. 21; thence along the line of that lot, and continuing, N. 51-20 E. 105 feet to an iron pin on the line of other property of John H.
