To All Whom These Presents May Concern:

We, Frank T. Merrill and Marian B. Merrill, of Greenville County,

SEND GREETINGS:

WHEREAS, I we the aforesaid mortgagor(s) in and by my/our certain promissory note in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAD ASSOCIATION OF GREEN-

VILLE in the full and just sum of Seven Thousand, Five Hundred & No/100 - (\$ 7,500.00 )

Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or hotes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Fifty Three and 74/100 - - - - - - (\$ 53.74 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 20 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said nete, shall, at the option of the holder, become immediately due and payable, and the holdermay sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum storney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said gebt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had; will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the spining of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as the front portion of tot 7, as shown on plat of property of J. R. Rodgers, recorded in Platimook V at Page 61, and being more particularly described according to a recent survey, prepared by J. C. Hill, September 25, 1951, as follows:

"BEGINNING at an iron pin on the western side of Howell Road, which pin is 290 feet North of the intersection of the Howell Road, and Old Spartagurg. Road, and is the joint front corner of lots 6 and 7, and running thence with joint line of said lots due West 200 feet to an Iron pin in line of property now formerly owned by Ponder; thence with the Ponder line, N. 5-55 W. 90 feet to an iron pin in line of lot 8; thence with line of lot 8, due East 200 feet to an iron pin in the Western side of Howell Road; thence with said Road, S. 5-55 E. 90 feet to the point of beginning; being the same property conveyed to us by Delbert J. Brown by his deed dated December 20, 1951 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 447, at Page 504."
