WHEREAS, the Mortgagor is well and truly indebted vinto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time, for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly pall by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and release, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of fand, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

being designated as lot # 17 on plat # 3 of Cherokee Forest, prepared by J. Mac Richardson, RLS, in January 1959, recorded in Plat Book QQ at Pages 36 and 37, and described as follows:

BEGINNING at an iron pin on the northern side of Roberta Drive, at the joint front corner of lots 6 and 7, and running thence with the line of lot 7, N. 10-31 E. 271.9 feet to an iron pin; thence turning and running S. 85-29 E. 100.55 feet to an iron pin; thence 8, 10-31 W. 282.4 feet to an iron pin on the northern side of Roberta Drive; thence with Roberta Drive, N. 79-29 W. 100 feet to an iron pin; the point of beginning.
