"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, shown as "hu northern poution of Lot No. 2 and the southern poution of Lot No. 3 on a plat of property of Walter J. Farr, recorded in the K.M.C. Diffice for Greenville County in Plat Book HH at Pare 123, and having the following metes and bounds, to wit:
