NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesand, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also inconsideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly-paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents of grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE) the following described property, to-wit:

"BEGINNING at an iron pin on the Southern side of Saran Drive at the joint front corner of Lots Nos. 64 and 65 and running thence with the joint line of said lots, S. 25-30°W. 160 feet to an iron pin at the northernly side of the right-of-way of the Southern Railway; thence with the northernly side of said right-of-way, S. 66-32 E. 90 feet to an iron pin at the joint rear corner of Lots Nos. 65 and 66; thence with the joint line of said lots, N. 23-37 E. 160 feet to an iron pin on the southernly side of Saran Drive; thence with the southernly side of Saran Drive, N. 65-33 W. 85.5 feet to an iron pin, the point of beginning, being the same conveyed to us by L. M. Brown by deed of even date, to be recorded herewith."

In addition to the above reentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes, and assessments next due on the mortgaged property (all as estimated by the mortgagee) less all sums already paid therefor, divided by the number of months to clapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by mortgagee in escrow to pay said premiums, taxes and special assessments.
