WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgages) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thous and Fifty and no/100---

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as a portion of Lot 43 and all of lots 44, 45 and 46 as shown on plat of the property of E. P. Kerns, recorded in Plat Book W at page 17, and being more particularly described according to said plat as follows:

BEGINNING at a nail in the center of Crestfield Road, at the intersection of said road, with White Horse Road, and running thence with center of Crestfield Road, N. 55 E. 100 feet to a nail; thence N. 46-15 W. 133.2 feet to a point in line of Lot 24; thence with line of said lot, S. 31-41 W. 12.5 feet to an iron pin, rear corner of Lot 44; thence with rear line of said lot; N. 55-21 W. 150 feet to a pin; thence S. 34-39 W. 150 feet to a pin on White Horse Road; thence with the White Horse Road, S. 55-21 E. 250 feet to the point of beginning.
