NOW, KNOW MLL MEN. That the Mortgagor, in consideration of the abovesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hegeby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain pieces rect or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs. Township, on Fuller Street in the City of Green, and being Lot No. 2 of the B.S. Robertson Estate according to survey and plat by H.S. Brockman, Surveyor, dated October 17 1945, recorded in Plat Book Q, page 101, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin, at the northeast corner of sail lot, corner of Lot No. 1, and in southern line of driveway leading to Colored cemetery, and running thence along the southern line of said driveway, N. 72-33 W. 141 feet; thence S. 16-15 W. 194.8 feet to corner of M.H. Thompson lot; thence along the northern line of the Thompson lot, S. 72-40 E. 138.7 feet to joint corner of Lots Nos. 1 and 3 on said plat; thence along the western line of Lot No. 1, N. 17-31 E. 194.5 feet to the beginning point.
