NOW KNOW ALL MEN, That I/we, the said mortgagor (s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

BEGINNING at an iron pin on the southern side of Prentiss Avenue, at the joint front corner of Lots Nos. 11 and 12 and running thence with the joint line of said lots, S. 44-33 E. 180 feet to an iron pin; thence S. 45-27 W. 65 feet to an iron pin at the joint rear corner Lots Nos. 10 and 11; thence with the joint line of said lots, N. 44-33 W. 180 feet to an iron pin on the southern side of Prentiss Avenue; thence with the southern side of Prentiss Avenue, N. 45-27 E. 65 feet to the point of beginning; being the same property conveyed to mortgagor corporation by Charles B.
