E.H.Edwards, his heirs and assigns forever; ALL that piece, parcel or lot of land in Chicksprings Township, Greenville County, State of South Carolina, and within the new cooperate limits of the City of Greer, and known and designated as lot 35 on plat of the Holtzclaw property as shown by plat prepared by W.N. Willis, Surveyor, January 19,1916, said lot lying on the North side of Palmer Street, and fronting thereon sixty (60) feet, with a rear width of sixty (60) feet and with depth one hundred thirty—seven and five tenths (137.5) feet on the easternn line and a depth of one hundred forty (140) feet on the western line.
