All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 21, North Garden Subdivision, plat of which is recorded in the RMC Office for Greenville County, S. C. in Plat Book EE, page 63, and having, a coording to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the South side of North Garden Circle, joint front corner Lots 20 and 21; and running thence along North Garden Circle S. 80-48 W. 75 feet to a nail cap; thence S. 9-12 E. 192.2 feet to an iron pin; thence N. 80-40 E. 75 feet to an iron pin; thence along the kine of Lots 19 and 20 N. 9-12 W. 192.7 feet to an iron pin on North Garden Sircle, the point of beginning.
