That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile north of Chick Springs, and lying 923 feet west of the St. Mark Road and on the north side of the McConnell Road, and being a part of the same tract of land conveyed to us by deed from Daisy Mitchell 1948, and being known as a part of the old Crowder place, and having the following courses and distances, to wit:-
