WHEREAS, the Mortgagor is well and truly indebted unto

called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of **Eleven Thousand Four Hundred**
Fifty and No/100----- Dollars (\$ **11,450.00**), with interest from date at the rate
of **five and one-fourth** per centum (**5 1/4** %) per annum until paid, said principal
and interest being payable at the office of **The Prudential Insurance Company of**

Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina: in the City of **Greenville**, on the eastern side of **Mayfair**
Lane and being known and designated as **Lot No. 33 of Holmes Acres** as shown on
plat thereof recorded in the **R. M. C. Office for Greenville County in Plat Book**
"Z", at **Page 1**, said lot fronting **80 feet** on the eastern side of **Mayfair Lane** and
runs back to a depth of **183.7 feet** on the north side and to a depth of **174 feet** on the
south side and is **80.62 feet** across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter

assigns forever.

to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against
the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
