Its successors and assigns and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

BEGINNING at a point in the center line of an abandoned road where the same bysects the center line of the old abandoned Landrum Road and runs thence South 70 Degrees East 220 feet to a point in the center line of South Carolina Highway No. 14; thence with the center line of said Highway South 15 Degrees West 495 feet to the center of Pacolet River; thence with the center of said River South 66 Degrees West 138 feet to the point of the center of said River where the old abandoned Landrum Road crossed said River, thence with the center line of the old abandoned Landrum Road about North 4 Degrees East 608 feet to the BEGINNING containing 2.4 acres more or less and being a part of Tract No. 7 and also a portion of the 267 acres more or less conveyed by Frank Owen to Ernest B. Kellogg as will appear by reference to Greenville County and Spartanburg County Deed registery, this being a portion of the former T. J. Earl Estate.
