"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot 448 on Plat of Gower Estates, Section D, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book RR, pages 192 and 193, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Pimlico Road, joint front corner Lots 447 and 448; and running thence S. 36-14 E. 126.5 feet to an iron pin; joint rear corner Lots 447 and 448; thence along the line of Lot 449 S. 62-33 W. 140 feet to an iron pin; thence along the line of Lot 451 N. 26-47 W. 65.3 feet to a point; thence along the line of Lot 452 N. 30-13 W. 97.9 feet to an iron pin on Pimlico Road; thence along Pimlico Road N. 86-05 E. 65 feet to a point; thence continuing along Pimlico Road N. 73-13 E. 65 feet to the point of beginning.
