"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, located on the Northweat side of Georgia Road, appromimately 3 miles east for the Town of Simpsonvile, adjoining lands of Mrs. Nina Miller, and Roy King and having according to a survey and plat made by E. E. Gary, Surveyor on July 23, 1949 the following metes and bounds, to-wit:
