WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Six Thousand, Two Hundred Fifty and 00/100

DOLLARS (\$6,250.00), with interest thereon from date at the rate of Six & one-half (6½%) per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying in the Town of Fountain Inn, and shown as Lot No. 11, on a plat of Woodland Heights Subdivision, recorded in the R.M.C. Office for Greenville County in Plat Book EE, at page 101, and having, according to said plat the following metes and bounds:

Beginning at an iron pin on the Western side of Woodland Drive at the joint front corner of Lots 11 & 12, and running thence with the joint line of said lots, N. 78-15 W. 266.9 feet to an iron pin; thence S. 8-00 E. 79.2 feet to an iron pin at the joint rear corner of Lots 10 & 11; thence with the joint line of said Lots, S. 78-15 E. 242.9 feet to an iron pin on the Western side of Woodland Drive; thence with the side of said drive, N. 10-E. 75 feet to an iron pin at the point of beginning.
