All that lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 190 on plat of Paramount Park subdivision recorded in Plat Book W at page 57 of the R. M. C. Office for Greenville County, S. C., said lot having a frontage of 80 feet on the south side of Mayo Drive, a depth of 80.2 feet on the southwest side, a depth of 120.4 feet on the northeast side, and a rear width of 90 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
