"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Fairview Township, and containing 8.8 acres, more or less, according to plat made by J. M. Bryson Jr., Surveyor, July 7, 1954, and, according to said plat, being more particularly described as follows:

BEGINNING at an iron pin on the east side of a county road, and running S. 77 E. 489 feet to an iron pin; thence N. 13 E. 425 feet to an iron pin; thence N. 81-30 E. 302 feet to an iron pin; thence S. 0-45 W. 688 feet to an iron pin; thence N. 88-15 W. 984 feet to an iron pin on the county road; thence along the right of way of said county road N. 21- E. 341 feet to an iron pin, the beginning corner, said property being a portion of the estate of J.
