NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Benjamin Avenue about one mile southward from Greer, Chick Springs Township, Greenville County, State of South Carolina and being shown and designated as all of lot No. 35 in Brookhaven, property of the Dobson Estates, according to survey and plat by H. S. Brockman, surveyor, dated December 12, 1975 amended September 1, 1959 and recorded in Plat Book RR at Page 41, R. M. C. Office for Greenville County and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Benjamin Avenue, corner of Lot Nos. 34 and 35, and running thence along the line of said lots S. 10-55 W. 170 feet to an iron pin, rear corner of Lot No. 56; thence along the line of Lot No. 56, S. 79-25 E. 100 feet to an iron pin, corner of Lot No. 36; thence along the line of Lot No. 36 N. 10-55 E. 170 feet to an iron pin on the South side of Benjamin Avenue; thence along said Avenue N. 79-25 W. 100 feet to the beginning corner.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one-half of one percent of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
