NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina,
being shown and designated as Lot No. 8 on plat of Glenwood Acres recorded in the RMC Office
for Greenville County, S. C. in Plat Book "AA", at Page 183.

Said lot fronts on the southerly side of Elmira Street 100 feet, has a depth of 173.8 feet on the
westerly side, a depth of 167.3 feet on the easterly side, and is 100.1 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
