TO ALL WHOM THESE PRESENTS MAY CONCERN: G. T. Simpson

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Andover Road and Colvin Road near the City of Greenville near the City of Greenville being shown as Lot No. 55 on a Plat of Heritage Hills, recorded in Plat Book YY at Page 187 and described as follows:
