"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Carolina, in Carolina, County of Carolina, Cou

being in the State of South Carolina, County of Greenville, in Greenville Township near the City of Greenville, on the east side of White Horse Road, being the main portion of Lot No. 20 and the rear portion of Lot No. 22 as shown on plat of the property of Mrs. B. E. Burns dated August, 1925, prepared by Dalton & Neves and recorded in the RMC Office for Greenville County in Plat Book G, Page 30, and according to said plat, being described as follows:

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
