WHEREAS, the Mortgagor is well and truly indebted unto

are incorporated herein by reference, in the principal sum of Fourteen Thousand Nine Hundred
-----Dollars (\$ 14,900.00), with interest from date at the rate
of five & one-fourth per centum (5 1/4 %) per annum until paid, said prin-
cipal and interest being payable at the office of Carolina National Mortgage Investment

sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its

All those lots of land in the county of Greenville, state of South
Carolina, on the northeastern side of Elaine Avenue, known and desig-
nated as Lots Nos. 37 & 38 as shown on plat of William M. Edwards
property recorded in plat book S, page 12 of the RMC Office for Green-
ville County, S. C., said lots having in the aggregate a frontage of
150 feet on the northeast side of Elaine Avenue, a depth of 275.8
feet on the northwest side, a depth of 270.1 feet on the southeast
side, and a rear width of 150.1 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
