TO ALL WHOM THESE PRESENTS MAY CONCERN:

Charles P. Mayers, III. and

Janet C. Mayers

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

known as Lot No. 70 in a subdivision known as Edwards Forest, Section 2, near Taylors, South Carolina, the same being shown on a plat by Dalton & Neves, dated March, 1957, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book RR, page 20, revised April 6, 1964 and recorded in Plat Book RR, page 20, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin at the joint front corner of Lots Nos. 70 and 71, fronting on Bridgewood Avenue (formerly Casselwood Street); thence N. 33-15 W. 180 feet to an iron pin at the joint rear corner of Lots Nos. 70, 71, 57 and 58; thence N. 56-45 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 70, 69, 58 and 59; thence S. 33-15 E. 180 feet to an iron pin at the joint front corner of Lots Nos. 69 and 70; thence along Bridgewood Avenue, S. 56-45 W. 100 feet to the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's account and collect it as a part of the debt secured by the mortgage.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one-half of one per cent of the principal balance then existing.
