NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Grove Township**, near the Augusta Road about 3½ miles from the Town of Piedmont, being a portion of "Tract #1" as conveyed to the mortgagors by deed of B.F. Hicks recorded in Deed Book 781 at page 29. The lot being mortgaged hereunder is more particularly described as follows:

BEGINNING at an iron pin on the southern side of Clearview Drive at the northwestern corner of "Tract #1" and running thence S. 13-15 W. 150 feet to an iron pin on the line of Hammond; Thence along the line of Hammond, S. 58 E. 150 feet to a point; Thence N. 13-15 W. 150 feet to a point on the southern side of Clearview Drive; Thence along said Drive, N. 58 W. 150 feet to the point of beginning.
