"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, about two miles northeast from the City of Greer on the south side of the Old CC Camp Road, being all of Lot No. 21 on a plat of property made for B.H. Burnett by J.Q. Bruce, Surveyor, dated February 6, 1950, and having the following courses and distances:

BEGIUNING at a stake on the southern edge of said road, joint corner with Lot No. 20 on said plat, and runs thence with the common line of Lots Nos. 20 and 21, S. 33-36 W. 167 feet to a stake; thence N. 88 E. 216 feet to a stake on line of Lot No. 23; thence N. 2-00 W. 51 feet to a stake on the southern margin of said road; thence therewith N. 56-34 W. 146 feet to the beginning corner.
