NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all Improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville and being described as follows:

BEGINNING at a point on the northern side of Frank Street, approximately 100 feet west of Pinckney Street, at the corner of property now or formerly belonging to Mrs. A. H. Whitmire and running thence west with Frank Street 97 feet, more or less, to the corner of property now or formerly belonging to W. B. Boggess; thence in a northerly direction parallel with Pinckney Street 220 feet, more or less, to property now or formerly belonging to A. H. Gregory; thence with the line of Gregory's lot and property now or formerly belonging to W. H. Brown in an easterly direction 97 feet, more or less, to property now or formerly belonging to H. P. The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
