PROVIDED, ALWAYS, nevertheless, that if the said Mortgagor shall pay or cause to be paid to THE PERPETUAL BUILDING AND LOAN ASSOCIATION OF ANDERSON, its successors or assigns, said debt, and all interest and amounts due thereon, then this deed of bargain and sale shall become rull and void; otherwise to remain in full force and virtue.

And it is further agreed by and between the said parties hereto, that the said Mortgagor is to hold and enjoy the said premises until default of payment shall be made.
