"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

1 O'Neal Township,

lyin on the State Park Road, opposite the Little Texas School lot, and containing one and 6/100 acres, more or less, and having the following metes and bounds:

"BEGINNING at the corner of Little Texas Road School lot and property now or formerly of W. O. Groce, in State Park Road, and running thence N. 17-00 W. 83.2 feet to an iron pin; thence W. 64-45 E. 340 feet to an iron pin on Batson line; thence S. 1 15 W. 100 feet to an iron pin by drive-way; thence S. 33-35 W. 235 feet along drive-way to point in center of Highway; thence N. 66-16 W. 163.7 feet to the beginning corner"!
