NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, in or near

the Town of Mauldin, and having, according to plat of property of Mrs. W. T. Sims prepared by C. C. Jones dated April 6, 1956, the following metes and bounds, to-wit:

BEGINNING at an iron pin, which iron pin is located N. 59-20 E. 625 feet from line, shown as being N. 31-30 W. 408.6 feet and 625 feet from line, shown as being N. 31-30 W. 408.6 feet and running thence N. 74-59 E. 272.8 feet to iron pin; thence N. 9-59 E. 88 feet to iron pin; thence N. 38-26 W. 30.1 feet to iron pin; thence N. 66-31 W. 157.1 feet to iron pin; thence S. 82-20 W. 151.5 feet to iron pin; thence S. 8-45 E. 226 feet to iron pin, the beginning corner, being a portion of the same property conveyed to W. T. Sims and Kathleen Sims by deed recorded in Deed Volume 472 at Page 122, W. T. Sims having died December 11, 1955, and having, by Will, left his entire estate to his wife, Kathleen Sims, said portion containing 1.25 acres.

EXCEPT, however, those two small pieces of property conveyed to Arthur Wallace, et al., in Deed Volume 783 at Page 263.
