All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Architects, Greenville in Gantt Township, on the Southern side of Alpha Drive, being shown as Lot No. 89, on a plat of Kennedy Park made by Piedmont Engineers and Architects dated September 28, 1964, revised on January 28, 1966, and recorded in the RMC office for Greenville County, S.
