We, the undersigned, M. E. HUDSON, LILLIAN M. HUDSON, AILEEN H. RHODES, MARY H. BREWSTER, JESSIE H. FREEMAN, NANCY JO HUDSON and LILLIAN H. SCARR, the owners and holders of a note and mortgage given to them by JOHN M. DILLARD, dated July 27, 1965, in the original sum of \$9,400.00, recorded in the RMC Office for Greenville County, South Carolina, in Mortgage Book 1002, page 237, covering 6.33 acres on the Eastern side of Hudson Road in Greenville County, South Carolina, do hereby release and fully discharge from the lien of said mortgage, the following described portion of said property, to wit:

ALL that tract of land containing 3.55 acres, more or less, lying at the terminus of a 50-foot proposed driveway off the Eastern side of Hudson Road, in Greenville County, S. C., being shown as Lot No. 3 on a Plat of the Property of John M. Dillard, made by H. C. Clarkson, Jr., RLS, dated August 18, 1966, revised February 14, 1967, and recorded in the RMC Office for Greenville County, S. C., in Plat Book QQQ, page 11, measuring 252.9 feet by 411.8 feet by 169.8 feet by 204.4 feet, by 258.3 feet by 320.5 feet, together with a strip shown and designated on said plat as a proposed driveway 50.2 feet wide, lying between Lot No. 3 and the Eastern side of Hudson Road, being 330.7 feet long on the Northern side and 337.4 feet long on the Southern side.

Except as hereinabove specifically released, the aforementioned mortgage shall remain in full force and effect, particularly insofar as the same shall constitute a first mortgage lien on Lots Nos. 1 and 2 on the aforementioned plat recorded in Plat Book QQQ, page 11, Lot No. 1 containing 1 acre, more or less, and Lot No. 2 containing 1.4 acres, more or less. The terms and conditions contained in this Release shall be and become binding upon the undersigned, their heirs, assigns, executors and administrators.
