TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Larry R. Marlowe,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on Woodleigh Drive, being known and designated as Lot No. 118 of COLONIAL HILLS, SECTION NO. 3, as shown on plat thereof prepared by Piedmont Engineers and Architects, May 7, 1965, and recorded in the R.M.C.
