All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Eastern side of Gayle Street near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 44 as shown on a plat of Rockvale, Section One, prepared by J. Mac Richardson, dated October, 1958, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at page 108 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Gayle Street at the joint front corner of Lots Nos. 43 and 44 and running thence with the line of Lot No. 43 N. 88-02 E. 160 feet to an iron pin; thence with the line of Lot No. 57 N. 1-58 W. 75 feet to an iron pin at the joint rear corner of Lots Nos. 44 and 45; thence with the line of Lot No. 45 S. 88-02 W. 160 feet to an iron pin on the Eastern side of Gayle Street; thence with the Eastern side of Gayle Street S. 1-58 E. 75 feet to the point of beginning.
