

MORTGAGE OF REAL ESTATE

WHEREAS, I, Jeff B. Raines

(hereinafter referred to as Mortgagor) is well and truly indebted un to B.P. Edwards

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two thousand three hundred and no/100- - - - - Dollars (\$ 2,300,00) due and payable Fifty dollars per month until principal and interest are paid in full-

with interest thereon from date at the rate of seven per centum per annum, to be paid: annually from date

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereot is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being the rear portions of Lots 3 and 4 of the property of Mallie Fortner, as shown on plat thereof, recorded in the R.M.C. Office for Greenvills County in Plat Book F, at page 73, and having the following courses and distances, to-wit:-BEGINNING at a point on the southwest side of Heatherly Drive, which point is 102.3 feet from the intersection of Heatherly Drive with Anderson Road, and running thence along the southwest side of Heatherly Drive, N. 50-34 W. 57 feet to an iron pin, joint corner of Lots No's 4 and 5; thence along the line of Lot No. 5, S. 37-20 W. 104.8 feet to an iron pin at the joint rear corners of Lots No's 2 and 3; thence along the joint line of said Lots, S. 50-34 2. 57 feet to a point; thence on a line through Lots No's 3 and 4, N. 37-20 E. 104.8 feet to the beginning corner, and being the same lot of land conveyed to me by deed from Jeff R. Raines, dated the 18th day of July, 1952, and recorded in the R.M.C. Office for Greenville County in Book 459, at page 299. This mortgage is second only to that certain mortgage executed to B.P. Edwards on the 2nd day of March, 1967, and recorded in the R.M.C. Office for Greenville County in Book 1051, at page 367.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
