"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being in Austin

Township, Greenville County, State of South Carolina, located on the north side of Trade Street in the Town of Simpsonville, adjoining lands of F. A. Crisp, et al., and having, according to a survey and plat made by E. E. Gary, Surveyor, on June 10, 1947, the following metes and bounds, to-wit:
