All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot 10, Section Two, on a plat of Richmond Hills recorded in the RMC Office for Greenville County in Plat Book JJJ page 81, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southerly side of Portsmouth Drive at the joint front corner of Lots 9 and 10 and running thence with a curve in Portsmouth Drive (the chord of which is N. 52-54 E.) 70 feet to an iron pin at the joint front corner of Lots 10 and 11; thence with the common line of said lots, S. 61-26 E. 150 feet to an iron pin; thence S. 28-34 W. 150 feet to an iron pin; thence N. 80-30 W. 97.4 feet to an iron pin; thence in a northerly direction 140 feet, more or less to the point of beginning.
