"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the southeastern side of Augusta Road in Gantt Township, being shown and designated as Lot 9-A on revised plat of the property of Albert Q. Taylor recorded in Plat Book X, page 130, of the RMC Office for Greenville County and being further described as follows:

BEGINNING at an iron pin on the southeastern side of Augusta Road at the joint front corner of Lots No.s 9 and 9-A, and running thence along the line of Lot 9, S. 43-36 E. 194.3 feet; thence turning and running N. 41-16 E. 72 feet to point; thence turning and running N. 41-18 W., 194.3 feet to an iron pin on the southeastern side of Augusta Road; thence along Augusta Road S. 45-00 W. 78.3 feet to the beginning corner.
