Credit Company (hereafter "Mortgagee") in the above Total of Payments and all future advances from Mortgagee to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real-estate together with all improvements thereon situated in South Carolina, County of GREENVILLE BEGINNING AT AN IRON PIN ON THE SOUTH SIDE OF CORNELL CT. AT THE CORNER OF LOT 23, AND RUNNING THENCE ALONG THE LINE OF THAT LOT, S. 24-42 W. 237.2 FEET, TO AN IRON PIN AT THE REAR CORNER OF SAID LOT; THENCE S. 72-10 E. 64 FEET TO AN IRON PIN AT THE REAR ON THE SOUTH SIDE OF CORNELL CT.; THENCE STILL ALONG THE SOUTH SIDE OF CORNELL CT.: N. 61-26 W. 122.9 FT. Any amount which Mortgagee may expend to discharge any tax, lien, assessment, obligation, covenant, insurance premium, prior mortgage or any charge whatsoever in connection with the above described real estate shall be an additional lien secured by this mortgage with interest at the highest lawful rate if not prohibited by law, and may be enforced and collected in the same manner as the debt hereby secured.

All obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand, upon any default.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
