## MORTGAGE

All that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 95 as shown on a plat of Glendale Heights Subdivision, said plat being of record—in the Office of the RMC for Greenville County in Plat Book KK at Page 143, reference to said plat being craved for a metes and bounds description thereof.
