

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Ned R. Arndt

... (hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF CREENVILLE, SOUTH CAROLINA (hereinaster referred to as Mortgagee) in the full and just sum of

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of _____

Two Hundred Forty-five and 09/100-----(\$ 245.09) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 • years after date; and

WHEREAS; said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot 144 in a subdivision known as Heritage Hills and plat being recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 187, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Butler Springs Road at the joint corner of Lots 143 and 144 and running thence with joint line of said lots, N. 76-30 W. 110 feet to an iron pin at the corner of lot 145; thence with the joint line of lots 144 and 145, S. 23-41 W. 169 feet to an iron pin on the northern side of old Spartanburg Road; and running thence with the northern side of old Spartanburg Road, S. 73-21 E. 115 feet to an iron pin at the intersection of Old Spartanburg Road and Butler Springs Road; thence with curvature of said intersection, the chord of which is N. 60-04 E. 34.4 feet to an iron pin; thence with the western side of Butler Springs Road, N. 13-30 E. 148.8 feet to the point of beginning.
